Frequently Asked Questions

When should I contact the COM?

If there is a concern that you feel is not being resolved adequately at the local church level, then you should contact us.

Who should we contact on the COM?

Ideally your Chair (E or W) or the Conference Minister should be contacted.

Who should contact the COM?

Ideally it would be a leader of the congregation, such as: the church's Moderator.

What is the first step after contacting the COM?

The COM will take your concerns confidentially and seriously as we desern how we might best respond.

Who will know that I have contacted the COM?

We will honor the confidence of any communication. Only COM members directly involved and, as needed, the Conference Minister will know.

What will the process look like?

Our goal is to facilitate healthy communication and to promote reconciliation and healing. Each situation is unique and will be handled as such.

Who We Are

The Committee on Ministry has the role of support and accountability of those seeking or holding standing in ministry. The COM attends to the operative covenantal relationships among those with standing, the Local Church, the ministry setting and the Conference. (Manual on Ministry p. 15)

In the UCC, *authorization for ministry* – determining who has the talents, experience and preparation to serve our churches and specialized ministries – is the responsibility of each Conference.

The Committee on Ministry guides individuals (Members in Discernment MIDs) as they prepare for Authorized (ordained) Ministry as well as those seeking Lay Ministry. COM works in covenant with all Authorized Ministers, whether parish or specialized. COM also has responsibility for approval of ministers from outside the PNC Conference seeking Transfer of Standing, Dual Standing, or Privilege of Call.

COM is comprised of clergy and lay. Both East & West, typically meet monthly, with additional meetings and preparation often necessary.

What We Do

We seek to equip clergy to minister to the best of their ability.

This is often joyful:

Supporting Members in Discernment on their path to ordination and those seeking to be Lay Ministers.

Ordinations, Installations and Farewell Services

Guiding chaplains seeking Ecclesiastical Endorsement

Other times it is challenging:

Fitness Reviews for ministers committing ethical violations.

Situational Support Consultations with ministers and/or churches seeking assistance with challenges.

Requirements for Standing

To maintain ministerial standing all Authorized
Ministers and Lay Ministers must meet the
following requirements:
Membership in a UCC Church
Attend the Conference Annual Meeting or
request an excuse from a COM chair.
Complete and return the Annual
Information Review Form
Boundary Training, approved by COM, once

Diversity, Equity, Inclusion and Belonging Training, approved by COM, every 3 years
